A basic daily care fee of up to 85% of the Australian single aged care pension will also be payable in addition to any accommodation payment or contribution. Residents may also be required to pay additional care related fees as directed by Government, depending on the outcome of their Services Australia/DVA means test assessment. As such, we encourage all prospective residents to seek independent legal and financial advice. Room layouts are an example only and may vary depending on the location of the room within the facility.

## Basic Daily Fee

**Set by the Commonwealth Government**

\$ 63.82 /day

Covers the basic living costs such as meals, cleaning, laundry, heating and cooling. Set by the Government and is 85% of the single person rate of the basic Age Pension. Everyone entering an aged care home is required to pay this fee.

## Means Tested Fee

**Set by the Commonwealth Government**

Contribution costs based on an individual's income and means assessment.

## Accommodation Fee

**Set by the aged care provider**

Covers the cost of accommodation, such as your room, bathroom facilities and access to all communal areas.
